The chairman remarked that the club was not there to make money but we couldn't afford similar losses in future. Some costs for next season will be higher some lower. Once all costs are known charges will be calculated and renewing members informed by 20 August.

#### **Bankiing**

Our current bank, Lloyds, have started charging a monthly fee. So, we will investigate alternative banks that do not charge a monthly fee. Members indicated their support.
